#### Camping and stayin with the SVR

You may be lokking for a place in rural suroudings for your holidays. For the peace, for example, or the contact with life and the animals at the farm. Or it is simply that you want to escape the crowds?

The SVR is familiar with the possibilities of camping and stayin in the country. Would you like te have addresses for a season site, holiday or a hiking tour? Just apply to the SVR with mentioning place, area or route.. Only supporters are supplied with addresses. We also have addresses in , for example, Belgium, France, Norway, Denmark, England, Switzerland and Germany.

#### Mini-campings spacious and simple

The SVR campings offer you a site or accommodation with simple, necessary provisions. There are toilets, washing facilities and also showers and electricity. Of course there are no cateens, slot machines and similar sources of amusement. You take care of your own amusement, for example by lending a hand on the farm or watching the animals. You may be able to help feeding or watch a cow calve. There are also addresses of private persons with an orchard, wood or market garden etc. where you are also most welcome.

#### A delightful stay at a low price

The SVR wants to make it possible for everyone to spend their holidays in the country. That's why the prices for camping and lodging have been kept reasonable. The SVR charges the following prices:

\*hikers: € 1,25 per person per night  
€ 0,50 per car per night  
€ 0,50 per (small) tent per night  
€ 1,75 for a big camper  
€ 1,25 for a family tent, caravan or a small camper

\*use of electricity:  
4 amp: € 1,25 per night  
6 amp: € 1,75 per night

\*hot showers:  
€ 0,50 per shower

\*pets: € 0,50 per night

These recommended prices are altered when the authorities necessitate this (think for instance of tourist tax). The rents of a part of the farmhouse, a cottage or caravan are determined by the landlord himself. In all cases there are adapted prices for groups.

#### Becoming a supporter takes only a few minutes

The SVR only provides its supporters with addresses. That may be a reason for becoming a supporter. As a supporter you pay a minimum of € 10,- per annum; groups, societies etc. pay a minimum of € 20,- per annum.

**Some items from the Statutes and the Rules and Regulations of the SVR (available on payment at the secretariat):**

The foundation aims at the stimulations of freedom and healthy competition in the recreation sector in the general interest. The foundation tries to realise this aim by mediating in the provision of recreation opportunities through camping at farms where sites are made available at a modest compensation.

Furthermore everything that may contribute in the widest sense of the word to the realisation of this objective. The board is authorised to refuse services to persons, if, in the opinion of the board, the rendering of the services would be conflicting with national health, public order and/or good manners, the aim of the foundation or the right procedure on the sites that have been made available.

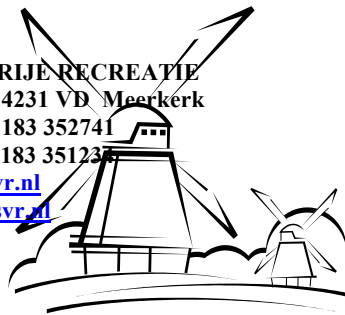
#### **Stichting Vrije Recreatie**

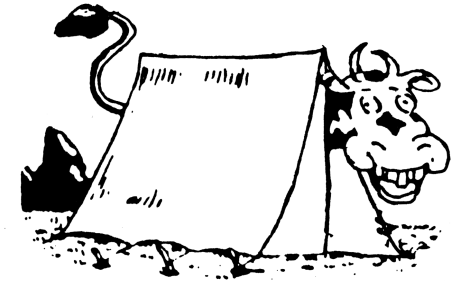
